



**MICRODIVE**  
**TRAINING PROGRAMME**  
**INSTRUCTOR TEACHING AGREEMENT**

The Microdive training programme is a generic programme consisting of established knowledge base theory, surface and sub-aqua skills. It is designed for those wishing to be able to dive to depths limited to 9 meters / 30 feet so the skill base required is limited to those needed to dive to that depth safely.

The Knowledge Base portion of the training programme is self-taught by the student via information provided in a training manual and DVD in which knowledge base information is provided as well as an insight into skills which should be mastered in order to dive safely.

Any current and insured instructor affiliated to any recreational diver training agency (must be recognised and approved by their host countries relevant authority) can:

- Review the quiz and the answers provided by the student in their log book and provide remedial assistance where required to confirm the student's understanding.
- Administer the performance-based skills circuit in confined water. The skills are performance-based so they must be mastered by the student to the same degree that you would expect from students on any other elementary scuba course.
- Administer the supervision of the 3 qualification dives.

You do NOT have to cross over to the Mini B recreational diver training agency to process a Microdive student.

### **TERMS**

I agree to abide by the terms listed below and understand that failure to do so will prohibit me from processing future Microdive students.

I agree to hold current professional instructor liability insurance to protect him/her/Microdive Ltd from liability of damage and loss, Including, but not limited to personal injury as Microdive Ltd does not hold or offer liability insurance for individual scuba instructors.

I agree not to act as a legal representative or agent in any form for Microdive Ltd and am not authorised to bind Microdive Ltd in any way.

I agree to process Microdive students in accordance with the Microdive standards and procedures that have been made available to me.

I agree to process Microdive students utilising the Microdive Liability & Express assumption of risk and personal medical questionnaire.

I agree to review the Microdive student's quiz with the student to confirm understanding before conducting confined or open water dives.

I agree that I am not currently, or have never been the subject of an investigation or proceedings against me from any recreational diver training agency.

I agree that I nor any other party connected to me from this date on may hold Microdive Ltd accountable for injury or death which might occur to a Microdive student while in my charge while undergoing any form of training endorsed or designed by Microdive Ltd.

I agree to notify Microdive Ltd immediately of any accident/ incident related to students participating in the Microdive course.

I agree to keep all relevant documentation relating to a student who I have processed for a period of 7-years and provide access to them as required.
